EU Regulation No 1907/2006/EC of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) is a regulation of the European Union, adopted to improve the protection of human health and the environment from the risks that can be posed by chemicals, while enhancing the competitiveness of the EU chemicals industry.

REACH also focuses on a specific group of hazardous substances, named "Substances of Very High Concern" (SVHC), by establishing specific obligations regarding them. A list of VHC Substances called "Candidate Substances" is updated twice per year by ECHA (the European Chemicals Agency). The presence of such substances in final products put on the market, should be notified to the customer if exceeding the 0.1% by product weight.

Based on our best knowledge and the information from our suppliers we confirm FILMAT GRZEGORZ SIEWIERA products do not contain any of these SVHCs above the threshold of 0.1% by weight. We support the goals of the REACH program, which are consistent with our own vision towards responsible use and handling of chemicals and hazardous substances.
